The company makes the following commitment statement:

The Management of INOXFIL undertakes the responsibility of furthering, in an ongoing and permanent manner, the implementation of an Integrated Management System according to the regulations stipulated in UNE-EN-ISO 9001 for Quality, UNE-EN-ISO 14001 for Environment, and UNE-EN-ISO 45001 for Occupational Health and Safety. The objective of this System is to achieve comprehensive development of the company based on the following principles of action:
